- Please ensure that no damage is caused or litter left behind at the conclusion of the trials.
- Under no circumstances are competitors to return to the trial grounds following the trial, or seek permission to train or hunt on the grounds.

SAFETY BRIEFING FOR RETRIEVING TRIALS

Trials are held over undulating and hazardous terrain so it is suggested that sturdy footwear and clothing be worn to reduce the possibility of scratches or injury. As with all outdoor activities it is suggested competitors and spectators have appropriate clothing for the weather and take due care when moving around the trial site.

The environment, animals and wildlife can be inhospitable. Be alert and avoid any inhospitable animals and wildlife where possible.

Trials are located near water. If you cannot swim take care around the water. If you have children in your custody it is your responsibility to ensure the safety and welfare of the children at all times.

Guns are used at trial sites and although using blanks all guns should be treated as if using live ammunition and appropriate gun safety should be used at all times. Trial Management will emphasize gun safety with competitors during the conduct of the trial.

Equipment used in trials is mechanical and if used incorrectly could cause injury. If you are unsure regarding the operation of the equipment familiarise yourself on how the equipment works before use.

We are privileged to be invited on to properties to run our trials and must respect the property owners' personal property and should therefore:

- Remove all rubbish from the property
- Do Not enter any dwelling on the property
- Do not touch any farm equipment on the property
- Ensure dogs are kept under control at all times especially around any livestock
- All gates must be left as they are found when entering paddocks

A first aid officer is available on the trial site and if first aid is required please contact the Trial Manager.

Retrieving and Field Trials and Gundog Ability Tests

Disputes Procedure

Purpose:

The purpose of this procedure is to facilitate the settlement of issues, that may be in dispute at any DOGS NSW Recognised Retrieving or Field Trial (Trial) or Gundog Ability Test (Test), in a consistent, equitable and amicable manner.

This procedure has been developed by the DOGS NSW Retrieving and Field Trial Committee (RAFT)¹ and is subject to the relevant ANKC and DOGS NSW Rules and Regulations, and any directions, limitations or requirements imposed by the DOGS NSW Board of Directors.

Application:

This procedure should be applied when issues are in dispute at any Recognised Trial or Test. Such disputes may include²:

- a) The meaning or interpretation of the relevant Rules and Regulations
- b) The rights or obligations of exhibitors
- c) The acts or omissions of an exhibitor, or
- d) Any matter or thing concerning or arising out of the conduct of a Trial or Test

Advice from RAFT:

In the event that an issue arises that relates to the application of the relevant Rules or Regulations any member may elect to seek advice from the NSW RAFT³. Requests for advice shall be in writing and will be addressed at the next scheduled RAFT meeting. Any subsequent advice issued by the RAFT shall not apply retrospectively and shall have no effect on disputes already decided by any Trial or Test Committee.

Definitions:

Club refers to any DOGS NSW affiliate conducting a Trial or Test.

Exhibitor includes any handler or owner etc. of a dog entered in a Trial or Test.

Committee includes persons appointed by a Club to conduct a Trial or Test. Note:-

Where only one appointed person is present at a Trial or Test that person shall nominate at least one further person to form a Committee for the purpose of dealing with a dispute.

Retrieving and Field Trials and Gundog Ability Tests Disputes Procedure

Disputes Procedure⁴:

1. In the event of any dispute arising the parties to the dispute shall initially try to resolve the dispute between themselves in a courteous and consultative manner.
2. In the event that the dispute cannot be resolved either party may elect to refer the dispute to the relevant Club Trial or Test Committee.
3. Upon referral of the dispute the Committee shall make such enquiry and investigation as it may consider appropriate and accept and act upon such evidence as it may think fit.
4. The decision of the Committee shall be final and binding upon persons affected thereby subject, however, to such right of appeal (if any) as may be granted by the Regulations.

Note: - A **Retrieving Trial Committee** may intervene if the Runs selected by the Judge contravene the Rules, are logistically unsound or the dogs' safety is in serious question (*Rule 67*). This right exists regardless of whether or not a dispute has occurred.

Obligations of Exhibitors, Judges, Stewards, Spectators Etc.

- Persons taking part in Trials and Tests must not openly impugn the actions or decisions of judges or engage in unsportsmanlike conduct.⁵
- Judges shall not openly discuss with any other persons the decision of any other judge. (*National Judges' Code of Practice for Field and Retrieving Trials – Code 18*)
- Persons shall not at any time, nor by any means: engage in improper conduct; disparage the decision of a judge; denigrate, malign, besmirch, slander, traduce, disparage or vilify the person or reputation of any other member; cause embarrassment to a judge or other persons; or attempt to influence a judge's decision.⁶

WORKING GUNDOG CLUB INC. COVID SAFE GUIDE FOR JUDGES & SAFETY MARSHALS

*Coronavirus is a significant threat for our retrieving community.
During this period our aim is to minimise any risks of infection.
Thank you for helping our club keep our patrons safe and well*

Shared use of the gun is considered to pose possible risk of Covid transfer.

At trial sites the *Judge* needs to establish a **Sanitation Station** in clear view of (but not closer than 4 metres from) the **Control Point**. The *Station* can be a club supplied table or similar flat surface e.g. a truck tailgate. The *Station* will hold club supplied sanitiser (liquid and/or wipes), disposable gloves, a box of tissues and a garbage bag and/or bin nearby.

The **gun**, with a supply of shells, must remain on or at the *Station* whenever it is not in use and should only be handled by competitors in succession. Judges should not appoint a Gun Steward. Instead, each competitor will be responsible for sanitising, loading and handling the gun under the supervision of a club appointed *Safety Marshal*.

The role of the **Safety Marshal** is to call, cue and supervise competitors in compliance with the club's *Covid Safe and Run Procedures*. If a competitor is unable to handle the gun the *Safety Marshal* may substitute for firing wearing gloves. If the *Safety Marshal* needs to be relieved, the *Safety Marshal* is responsible for ensuring their replacement is familiar with safety procedures.

Game Stewards should be appointed and coordinated by the *Judge*. All *Stewards* handling throwers, birds or common equipment **MUST** be directed to wear gloves (available from the *Club Secretary* or the *Sanitation Station*). When duties end *Stewards* must dispose of their gloves safely and wash or sanitise their hands thoroughly.

Judges need to maintain physical distancing (minimum 1.5 metres) from *Competitors* and *Stewards* at all times. **Runs** should be explained to groups of 5 competitors or less by the *Judge*. Whenever multiple competitors are assembled the *Judge* is responsible for ensuring that physical distancing is observed. The *Judge* is required to announce the results of the trial to competitors at the trial site and distribute ribbons and prizes (available beforehand from the *Club Secretary*) to the placegetters on behalf of the club.

Run Procedures

1. 'Next Competitor' is called by the *Safety Marshal*
2. *Handler* then proceeds to the *Sanitation Station* with dog on lead
3. Vetting (entire bitches at 1st run only) is performed by the dog's handler in the presence of the *Safety Marshal* who confirms clearance with the *Judge*
4. *Handler* then sanitises hands, the gun and dons other Covid protection if required
5. On instruction by the *Judge*, *Handler* takes possession of gun, shells and proceeds to the Control Point with dog on lead
6. At the Control Point, *Handler* steadies the dog, removes lead and places it on the ground
7. Run is completed as directed by the *Judge*
8. Retrieved game is placed where directed for inspection and dog is placed back on lead
9. Following release by the *Judge*, the *Handler* places game in a storage bin, returns the gun and spent shells to the *Sanitation Station*, then vacates the area.

ENTRY INFORMATION FOR WGC RETRIEVING, RATG & TRAINING EVENTS

This event will involve differences in the ways we have previously managed our trials. Changes have been made with your personal safety in mind. Please familiarise yourself with this information, be careful, patient, follow instructions and have a great weekend.

Attendance at this trial is subject to strict compliance with our COVID Safety Procedures. **IMPORTANT:** Any person who has visited a government listed COVID 19 Lockdown Area, Restricted Facility or Hot-Spot within 14 days of this trial **MUST NOT** attend.

ENTRY INFORMATION

- Entry will only be available through the EASY DOG ENTRIES online entries system <https://www.easydogentries.com.au>
- The Catalogue will be emailed to competitors prior to the trial. Please print and bring a copy of the Catalogue with you only very limited copies will be available at the event. The catalogue will also be available to download via a link on the Retrieving Australia Trials Index webpage.
- The marked Catalogue will serve as a record of attendees for contact tracing purposes. Handlers who are not the registered owners of an exhibit and non-competitors (e.g. relatives and guests) **MUST** register their attendance, preferably in advance online, or on arrival. **Handlers and Guests can complete this online [Contact Tracing Registration Form](#) now to reduce queuing and gathering at the trial.**

BEFORE AND AFTER TRIALS

- **Morning Muster** - Attendees should assemble near and around the camping area by 7:15am. Avoid gathering in groups of more than 5 and practice physical distancing (1.5 mtrs) from others.
- **Check-in** - If attendees have not pre-supplied contact details they must visit the Club Secretary on site preferably wearing a mask to be checked-in.
- **Vetting** will take place at the separate stakes (see *Run Procedures*).
- **Catalogues and Exhibit number cards** will not be supplied at this trial.
- **Daily Trial Briefings** will be held in the open at 7:30am sharp followed by a brief opportunity for questions. Attendees will then follow a judge (or delegate) in cars directly to the designated trial sites. Physical distancing (1.5 mtrs) must be maintained at all briefings.
- There will be no combined **afternoon Presentations** at this event. Placegetters will be announced by the judge and receive ribbons and prizes in the field at the end of each competition. Placings will be posted on Retrieving Australia.

AT STAKES

Runs will be explained by the judge to groups of 5 competitors or less in catalogue order.

Run Procedures

1. 'Next Competitor' is called by the *Safety Marshal*
2. *Handler* then proceeds to the *Sanitation Station* with dog on lead
3. Vetting (entire bitches at 1st run only) is performed by the dog's handler in the presence of the *Safety Marshal* who confirms clearance with the *Judge*

5. On instruction by the *Judge*, *Handler* takes possession of gun, shells and proceeds to the Control Point with dog on lead

- When not competing or performing official functions attendees are encouraged to stay in their cars as much as possible. When this is not possible attendees must maintain safe physical distancing from others.

COVID SAFETY PROCEDURES

Please observe our Covid Safety Procedures copies of which can be read here. In the trial Catalogue, and will be explained at trial briefings. Signage will be placed at the entry points of trial grounds with the Trial Manager's name and contact number. Social distancing and Sanitiser signs will also be on display in appropriate locations.

If any person suspects that they have Covid 19, or have been with someone that has or may have Covid 19, then they **MUST NOT** enter the trial site. If any person at the trial develops symptoms such as shortness of breath, sore throat, coughing or high temperature they are to inform the Trial Manager and remove themselves from the trial site.

Physical Distancing

- All attendees must maintain a minimum 1.5 metres apart from each other at all locations and times.
- There should be no unnecessary congregating in sheds, covered areas and grounds.
- Where outdoor gallery viewing areas are assigned by a judge at a stake, spectators who are not from the same household must remain seated 4 square metres apart at all times.
- People traveling around the trial site in vehicles are to maintain safe distancing wherever possible unless they are in a formal relationship or members of the same household.

Hygiene

- Sanitiser, gloves and appropriate PPE will be provided by the club at trial sites for use by competitors. Attendees are encouraged to also provide their own protection. Face masks may be worn by attendees but are not compulsory.
- Stewards MUST use gloves when handling game, guns, throwers, pegs etc. and wash or sanitise their hands thoroughly immediately following duties.
- Do not greet others physically with handshakes etc. Practise good hygiene by cleaning your hands thoroughly with soap and water or sanitiser after visiting a common area, blowing your nose, coughing, or sneezing etc.
- Be considerate and maintain appropriate hygiene and distancing when visiting restrooms.
- Avoid touching dogs that are not your responsibility.

CAMPING GROUNDS

- **Raffles and Catering** may be restricted. Attendees should bring sufficient supplies of food and drink including fresh water for dogs and hand washing.

Social Gatherings may be permitted at designated area/s but strictly limited to 20 people who must remain 1.5 metres from each other at all times. **Private gatherings at caravan/tent sites** should not exceed 10 people with physical distancing and safe practices observed at all times.

The Working Gundog Club Inc. has a NSW Government exemption to conduct competitions under Community Sporting Competitions & Full Training Activities Covid-Safe Guidelines. This document may be amended at any time as directed by Dogs NSW or as government restrictions dictate.
